2.	Application for Extension of Licensed Hours	
(a)	Neil A Doull The Solicitor introduced the application and advised that Mr A Doull was present to represent the application.	GRANTED
	Reference was made to the last line of the comments provided by the Licensing Standards Officer and, if approved, whether future applications would be presented to the board. The Solicitor confirmed that the Statement of Licensing Policy allows for future applications to be approved under delegated authority should this initial application be approved by the Board.	
	Mr Cooper noted that the hop rotates between different halls and this is the year for the Sullom and Gunnister Hall to host the hop. He commented that this is a special event for the area of Northmavine and moved that the Board grant the Extension of Licensed Hours. Mr C Smith seconded.	
	Mr Bell expressed his concern, stating he had the same concerns as he had previously in that although the intention was to allow more drinking up time, there was no provision within the legislation beyond 15 minutes drinking up time and the effect of the application was that drinking could continue to 2am.	
	Mr Doull was invited to speak in support of the application and explained that the 2am extension was intended to bring the event to a controlled wind down. He said that the kitchen would be open for food and it would mainly be soft drinks at that time.	
	Mr Bell said that this approval would set a dangerous precedent and moved as an amendment that the Board refuse the Extension of Licenced Hours. There being no seconder the Chair advised that the motion stood and the application was granted.
