4	Climate Change – "Just Transition"	 NOTED the alignment of Shetland Islands Council Net Zero Route Map preparation with the outcome objectives and best practice processes for "Just Transition" RESOLVED to promote the case for Shetland to be prioritised in planning and delivery of "Just Transition". The Islands should be recognised as a region of the highest priority given the scale of local employment in industries likely to be affected significantly and early by decarbonisation; the local dependency on hydrocarbons for the delivery of essential lifeline services, the dependency on hydrocarbons of key local economic sectors and in providing many communities and families basic energy needs.
5	Future Energy – "Just Transition"	 NOTED the alignment of Shetland Islands Council energy transition priorities with the outcome objectives and best practice processes for "Just Transition" RESOLVED and APPROVED the draft engagement activity described in section 2 of Appendix 1 and to promote the draft principles for energy development as set out in draft in section 3 of Appendix 1 with prospective developers, to inform them of Shetland priorities and seek their alignment with the delivery of those principles should they bring any projects forward in the Shetland area.
